

Ozroll ODS Control 10 Battery Replacement Instructions using non-genuine batteries.

These instructions detail the required procedure to replace the battery in all Ozroll Control 10 products (RF and Non RF).

These will be product's with part numbers 15.200.001, 15.202.001, 15.205.001, 15.206.001

1) Using the tool supplied remove the screw on the back panel of the controller.

2) Slide the back of the controller down (it will only move approximately 6mm). Refer to Figure 1.

3) Lift off the back of the controller to expose the battery.

4) Pull the bottom (connector end) of the battery upward to release the connector. The battery should come free, quite easily. Refer to Figure 2

5) Fit the new battery with the label facing upward. Slide the top of the new battery into place, and then fit the connector to the controller board, ensure the connector is a good fit.



6) Press the battery down so that it sits flat.

7) Refit the back panel of the controller, check it is in the correct position and slide it up into place. Press at the top of the back panel to guide the tip into position.

8) Refit the screw on the back panel, being careful not to over tighten the screw.

Before use charge the controller as normal allow the battery to fully charge. The red LED on the front of the controller will be Lit when the controller is charging.(charging may take from 5-8 hours).The red light indicates that the charger is working and the battery is accepting charge.
