OZRoll Battery Replacement INSTRUCTIONS

Part Number 15.300.014 Version 01 - JANUARY 2008

These instructions detail the required procedure to replace the battery in all OZRoll "Control 10" products (RF and Non RF).


These will be products with part numbers: 15.200.001, 15.202.001, 15.205.001, 15.206.001.


- 1. Using the tool supplied remove the screw on the back panel of the controller.
- 2. Slide the back of the controller down (it will only move approximately 5mm). Refer to Figure 1.



3. Lift off the back of the controller to expose the battery.

4. Pull the bottom of the battery upward to release the connector. The battery should come free quite easily. Refer to Figure 2 and Figure 3.





- 5. Fit the new battery with the grey pad facing upward. Note that the new battery is a different colour. Slide the top of the new battery into place, and then fit the connector to the controller board.
- 6. Press the battery down so that it sits flat.
- 7. Refit the back panel of the controller. Check it is in the correct position and slide it up into place. Press at the top of the back panel to guide the lip into position.
- 8. Refit the screw on the back panel.

The battery will need to be charged before use. Charge the controller as normal and allow the battery to fully charge. The red LED on the front of the controller will be lit when the controller is charging.

If the controller is not working properly check the above instructions have all been followed correctly. If problems persist refer to the place of purchase.

Product Warranty - OZRoll guarantees the battery for 6 months from date of purchase against any defect in materials or workmanship under conditions of normal use and service.

- 3. The defect was caused by an accident, misuse, abuse, improper installation or operation, lack of reasonable care and maintenance, unauthorized modification, loss of parts, tampering or attempted repair by a person not authorized by OZRoll.
